I UNDERSTAND THAT A TRIP CHARGE OF \$65.00 WILL BE APPLIED IF CONTAINER IS NOT READY WHEN PICK-UP IS ARRANGED OR IF CONTAINER HAS BEEN OVERLOADED. I ALSO UNDERSTAND THAT IF CONTAINER HAS BEEN MOVED FROM THE ORIGINAL AREA DROPPED; BURNETT SALVAGE YARD INC. WILL NOT BE HELD RESPONSIBLE FOR ANY DAMAGE THAT MAY OCCUR, IN OR AROUND AREA DURING PICK-UP.
